## Man kills wife, self in NE Delhi

**New Delhi:** A 56-year-old man allegedly murdered his wife and then killed himself at his house in northeast Delhi on Monday night.

The couple, residents of Karawal Nagar, were having domestic problems for some time, police said adding that they were still investigating what triggered the man, Rajveer, to resort to such an extreme step.

Rajveer first attacked his wife, Santosh (50), with a blade and then strangled her to death. He then slashed his wrist. Police were alerted about the murder in the early hours. The two were declared dead on arrival at a hospital and the bodies were handed

# रिकवर होते मरीजों को डायबिटीज की गिरफ्त में लेता है कोरोना?

## कोविड से उबरने के दौरान ब्लड शुगर पर नजर रखना जरूरी, जरूरत पड़ते ही लें डॉक्टर से सलाह

नई दिल्ली : जहां एक ओर डॉक्टरों का कहना है कि कोविड-19 के मरीजों में डायबिटीज से जटिलताएं बढ़ जाती हैं जिसमें मृत की आशंका तक शामिल है, वहीं अब यह बात भी सामने आई है कि कोरोना से रिकवर होने के बाद कई मरीजों में ब्लड शुगर लेवल बढ़ने की समस्या भी देखी जा रही है। इनमें से ज्यादातर मामलों में मरीजों को कुछ समय तक दवाओं की जरूरत भी पड़ती है, जिसमें टेबलेट से लेकर इंजुलिन तक शामिल है।

### क्यों बढ़ता है डायबिटीज

जहां इस बात को लेकर रिसर्च जारी है कि आखिर वायरल इन्फेक्शन से रिकवरी के बाद डायबिटीज की दिक्कत क्यों होती है, वहीं मद्रास डायबिटीज रिसर्च फाउंडेशन की सीनियर डायबेटोलॉजिस्ट डॉ. आर. एम. अंजना इसके लिए तीन अलग-अलग वजहों को जिम्मेदार मानती हैं। यह संभव है कि कई मरीजों को कोविड संक्रमित होने से पहले से ही डायबिटीज रहा हो, लेकिन उन्हें इसका पता ही नहीं हो। इसकी संभावना का पता लगाने के लिए डॉक्टर HbA1c (हीमोग्लोबिन A1c) टेस्ट कराने की सलाह देते हैं। इसके अलावा कोविड के

इलाज के लिए भर्ती मरीजों की रैंडम शुगर लेवल टेस्ट कराने को भी कहा जा सकता है। HbA1c टेस्ट किसी व्यक्ति में तीन महीने की अवधि के दौरान औसत ब्लड शुगर लेवल बताता है। डॉ. अंजना कहती हैं कि अगर HbA1c लेवल 6.5% से ऊपर है तो इसका मतलब है कि मरीज को पहले से ही डायबिटीज था और यह कोविड के इलाज के दौरान संयोग से पता चल गया।

वहीं, कोविड के मध्यम से लेकर गंभीर रूप से संक्रमित मरीजों को डेक्सामिथासोन जैसे स्टेरॉइड की डोज दी जाती है और यह भी ब्लड शुगर लेवल को बढ़ा सकता है। यह उन मरीजों को डायबिटीज की हालत में पहुंचा सकता है जो अब तक प्री-डायबिटीज स्टेज में थे। उन्होंने कहा कि इसके अलावा बहुत से भारतीय लोगों में एक जेनेटिक प्री-डिस्पोजिशन भी होता है जोकि उन्हें डायबिटीज होने का खतरा पैदा करता है और कोविड संक्रमण के कारण इन्सुलिन सेंसिटिविटी बढ़ जाते हैं जिससे यह प्रॉसेस तेज हो जाता है। इसकी भी आशंका होती है कि वायरस सीधे तौर पर पैन्क्रियाज (अग्नाशय) को प्रभावित करता है जिससे इंसुलिन की मात्रा में कमी आ जाती है।

### खानपान का रखें ध्यान

चेन्नै स्थित डॉ. मोहन डायबिटीज



स्पेशलिटीज सेंटर के सीनियर डायबिटिशियन डॉ. थॉमस सुरेश की सलाह है कि पोस्ट-कोविड रिकवरी के लिए घर पर बना संतुलित आहार लें जिसमें नट्स (सूखे मेवे), सब्जियां, फलीदार सलाद, ताजा जमाया हुआ दही और ढेर सारा सादा पानी शामिल हो। बेहतर होगा कि हरेक मरीज डायबिटिशियन की सलाह से अपना पर्सनल डायट चार्ट बना लें, क्योंकि हाई बीपी या किडनी के मरीजों का डायट चार्ट उस व्यक्ति से अलग होना चाहिए जिन्हें कि केवल डायबिटीज की

समस्या है। आमतौर पर डायबिटीज की दिक्कत से जूझ रहे लोगों को हाई शुगर कंटेंट वाले ड्रिक्स, मिठाइयों, चॉकलेट्स और ज्यादा स्टार्च वाले फूड की मात्रा को कम करने की जरूरत होती है।

### दूसरी तरह की दिक्कतें

कुछ मरीजों में खांसी, सांस लेने में तकलीफ, सिरदर्द, शरीर में दर्द जैसे कोविड-19 के लक्षण 28 दिन तक बने रह सकते हैं। हरेक मरीज के अपने इम्यून सिस्टम के हिसाब से ये लक्षण

अलग-अलग होते हैं। ऐसे मरीजों को आइसोलेशन पीरियड के दौरान उनके ब्लड शुगर लेवल की नियमित मॉनिटरिंग की जरूरत होती है। कोविड-19 से रिकवरी के बाद गंभीर फंगल इन्फेक्शन (म्यूकोमाइकोसिस या ब्लैक फंगस) का भी खतरा रहता है, खासकर जिन मरीजों का डायबिटीज लेवल अनियंत्रित होता है उन्हें यह खतरा ज्यादा होता है। ब्लड ग्लूकोज को अच्छी तरह नियंत्रण में रखकर ब्लैक फंगस जैसे खतरे को कम किया जा सकता है।

### रिकवरी के बाद कैसे करें देखभाल

अगर कोविड के इलाज के दौरान आपका वजन काफी घट गया है तो आपका टारगेट अपने मसल्स स्ट्रेथ को बढ़ाना होना चाहिए। लेकिन अगर आपका वेट लॉस नहीं हुआ हो और यह निर्धारित बीएमआई (25) से ज्यादा हो तो आपको इसे कम करने पर काम करना चाहिए। एक्सरसाइज, जैसे कि वॉकिंग आदि से इंसुलिन की सक्रियता को बनाए रखने और डायबिटीज पर कंट्रोल में मदद मिल सकती है। हालांकि बेहतर होगा कि कोरोना संक्रमण से उबरने के बाद शरीर पर ज्यादा बोझ डालने वाले कड़े एक्सरसाइज मरीज न करें। स्लो और लगातार रिकवरी का मंत्र ही आपके लिए बेस्ट होगा।

### इन लक्षणों को ना करें नजरअंदाज

कोविड मरीजों को ज्यादातर अस्पताल डिस्चार्ज होने के एक महीने के बाद शुगर टेस्ट कराने की सलाह देते हैं जबकि 3-6 महीने के बाद यह टेस्ट रिपीट करने को कहा जाता है। मरीजों को सलाह दी जाती है कि अगर उन्हें बार-बार यूरिन आने, ज्यादा प्यास लगने, धुंधला नजर आने, अचानक तेजी से वजन गिरने, घाव के भरने में काफी वक्त लगने और ज्यादा थकान जैसी दिक्कतें होने लगे तो वे हॉस्पिटल में रिपोर्ट करें। ज्यादातर डॉक्टर कोरोना से रिकवरी के एक महीने बाद मरीजों को दोबारा उनसे मिलने की सलाह देते हैं ताकि वे कोविड के बाद होने वाली दिक्कतों की जांच कर पाएं।

We work to ensure that Adivasis, Dalits, Muslims, and women and girls have safe-violence free lives with freedom to speak their mind, equal opportunities to realize their rights, and a discrimination free future. We research to find lasting solutions to end rising inequalities and exclusion of marginalized communities from getting decent jobs, quality free education and healthcare. We campaign with the public to demand policy changes from governments for creating a just and inclusive country as envisioned in the Indian Constitution. We mobilize support to save, protect and rebuild lives of the poorest of poor affected by crisis and humanitarian disasters. We are also part of the Oxfam global confederation with affiliates in 20 countries fighting together build a better world.

2.The present complaint is being filed against the handlers of the website www.91oxfam.com , who are cheating innocent people by alluring them to believe that the said website is being run by our organization OXFAM India of international repute, and inviting them to invest online and earn good returns. The contents of the said website shows that the handlers of '91oxfam.com' have used the brand name, work and good will of our organization Oxfam India to misrepresent and commit fraud on the people. Print out of the website is annexed herewith as Annexure-A1.

3.That we came to know about the aforesaid fraud being committed actually we are getting calls in Oxfam India office from peoples who are cheated through 91oxfam website. On their website they are using our brand name, logo, office address and landline phone nos. Peoples are continuously calling to Oxfam India for recovering the money.

4.Upon investigation by our officials it was found out that some persons are running a website www.91oxfam.com thereby unauthorized use of Oxfam name to collect funds from public. In the Introduction part of the website, it was mentioned that a private equity fund is working through Oxfam to promote self- help for poor and unemployed in India due to pneumonia epidemic. It has been categorically mentioned there that the initial private fund of this project drives the poor and unemployed people's small funds to make profits in the lottery market, so as to achieve the purpose and goal of "helping others to help themselves and fight poverty".

It is clarified that the Oxfam India is not engaged in any sort of business of lottery

In view of the abovementioned facts and circumstances, it is crystal clear that the handlers of the above named website www.91oxfam.com have committed offences of cheating and fraud and have maligned the name of Oxfam India which are punishable under the provisions of the India Penal Code.

Therefore, I hereby request you to register a criminal case against the above named accused persons and take appropriate action against them.
