

SUMMARY OF DFI INVESTMENTS IN PRIVATE HEALTHCARE IN INDIA

The table below lists the various investments in private hospitals and diagnostics in India made by IFC, DEG, BII, Proparco, ADB and DFC. This includes only the name of companies which could be traced to DFI or intermediary investments and is likely to be an under-estimate.

The list of IFC investments is based on the analysis done in the main report¹. The list of investments made by Proparco, DEG and BII is drawn from the analysis done for Oxfam's report "Sick Development".² No investment in these sub-sectors in India could be traced for EU's EIB as part of the above analysis. DEG and ADB investments are based on disclosures on their websites in January 2023.

In the table below, rows in green are the direct investments (including investments in Funds). Any investments made through intermediaries are listed under the concerned intermediary.
